You are able to search by the date it became a Medical Examiner's case, First Name, Last Name, or combination First and Last Name.

* To search by Date, click on the "Body Received Date" field and select your date from the pop-up calendar. Click "Search Date".

* To search by Name, enter either the first or last name into the boxes and click "Search First Name" or "Search Last Name". You may also put in both a first and a last name and click "Search First & Last Name". Partial Names can be searched in the following way: First Name "Ma" Last Name "Smith" will return both Matthew and Maurice Smith on the list.
